使用上の注意

- 基礎統計の一つである「毎月勤労統計」(厚生労働省)の訂正(2019年10月23日)に伴い、2019年7-9月期1次QE公表時に2018年7-9月期以降の原系列を改定した。  
(2018年10-12月期1次QE公表時には、「毎月勤労統計」の500人以上規模事業所の再集計に伴い、2004年以降の原系列を改定している。2004年から2011年については暫定的な方法の補間推計である。)
- 季節調整系列については、1994年1-3月期～直近期の原系列に季節調整を行い作成している。なお、季節調整系列は毎回1994年1-3月期まで遡りて改定されることから、最新の速報を利用されたい。
- 実質値については、名目雇用者報酬を家計最終消費支出(除く持ち家の帰属家賃及びFISIM)デフレーターで除して算出した参考値。
- 2007年10-12月期以前の計数は、SNAホームページを参照されたい。

## ・ 寄与度の計算方法について

実質 GDP 成長率に対する各内訳項目（項目  $i$ ）の寄与度計算は、以下のように行っている。

寄与度の合計とベンチマーク（比例デントン法）後の増加率の開差は比例的に配分している。

年率寄与度は、前期比寄与度の 4 倍をベースとし、その合計と GDP 成長率（年率）との開差は比例的に配分している。

寄与度の合計と増加率の開差は比例的に配分している。

## 留意点

- (1) 「純輸出」については、寄与度の符号が前期差の符号と逆になることがあり得る（純輸出実質額は「輸出 - 輸入」の実質額の単純引き算により求めているため）。この場合、寄与度の与える符号が正しいものである。
- (2) 「国内需要」「民間需要」「公的需要」「総固定資本形成」「最終需要」の寄与度は、下位内訳項目の寄与度計とは一致しない。
