使用上の注意

- ・基礎統計の一つである『毎月勤労統計』（厚生労働省）の訂正（2020年11月5日）に伴い、2019年4-6⽉期以降の原系列を改定した。（2020年7-9⽉期1次QE公表時）
- ・『毎月勤労統計』の500人以上規模事業所の再集計に伴い、2004年から2011年については暫定的な方法の補間推計となっている。
- ・季節調整系列については、1994年1-3⽉期から直近期の原系列に季節調整を行って作成しており、毎回1994年1-3⽉期まで遡及して改定されることから、最新の速報を利用されたい。
- ・実質値については、名目雇⽤者報酬を家計最終消費支出（除く持ち家の帰属家賃及びFISIM）デフレーターで除して算出した参考値。
- ・本時系列表は、2009年1-3⽉期以降を掲載している。最新の全計数（1994年1-3⽉期以降）については、四半期別GDP速報ウェブサイト上のCSV形式ファイルを参照されたい。

・ 寄与度の計算方法について

実質 GDP 成長率に対する各内訳項目（項目 i ）の寄与度計算は、以下のように行っている。

$p_{i,t}$: t 暦年の下位項目デフレーター, $q_{i,t}^{(k)}$: t 暦年(第 k 四半期)の下位項目数量指数, T : T 年度(t 暦年第 2 四半期 ~ $t+1$ 暦年第 1 四半期)

寄与度の合計とベンチマーク（比例デントン法）後の増加率の開差は比例的に配分している。

年率寄与度は、前期比寄与度の 4 倍をベースとし、その合計と GDP 成長率（年率）との開差は比例的に配分している。

寄与度の合計と増加率の開差は比例的に配分している。

留意点

- (1) 「純輸出」については、寄与度の符号が前期差の符号と逆になることがあり得る（純輸出実質額は「輸出 - 輸入」の実質額の単純引き算により求められているため）。この場合、寄与度の与える符号が正しいものである。
- (2) 「国内需要」「民間需要」「公的需要」「総固定資本形成」「最終需要」の寄与度は、下位内訳項目の寄与度計とは一致しない。
